Video-clip competition with lyrics

Terms and conditions for participation

- 1. Competition, content and technical guidelines
- 1.1 The video-clip competition is being jointly organised by the Goethe-Institut / Max Mueller Bhavan Kolkata and the PASCH-Initiative.
- The competition aims at producing a video-clip with lyrics for any one of the two songs 1.2 German band RAGGABUND: Radio the reggae lm 2.0 (https://raggabund.bandcamp.com/track/im-radio-20) and Ohne Kompass (https://raggabund.bandcamp.com/track/ohne-kompass-feat-blumentopf). At least 25 words of the song-lyrics must appear in the video-clip in written form in German. Apart from the text, the video-clip must also contain appropriate original and creative moving images. Creativity plays an important role for the selection.

1.3 The video-clip should be in one of the following formats: .WMV, .AVI, .MOV or .MPG. The video-clip should not be more than 100 MB in size.

2. Participation and sending of entries

- 2.1. All German language learners in schools in Kolkata who are currently studying in 8th to 11th Standard can participate in the competition.
- 2.2. This competition is a group entry and a group consists of two people. Individual entries shall not be entertained.
- 2.3 From a given school <u>a maximum of five groups</u> can register for the competition. The groups are to be registered collectively by the school together with the consent of the school and parents.
- 2.4 The video-clip should be saved as a file bearing the name of the working group (e.g. *Aditi_Bina_XYZschool.mpg*).
- 2.5 All participating schools must send in their entries in digital format via **WE-TRANSFER** (www.wetransfer.com) to the Goethe-Institut / Max Mueller Bhavan Kolkata at the e-mail ID sagarika.chatterjee@kolkata.goethe.org along with the duly filled-in and signed registration form as well as the consent form.
- 2.6 The last date for receipt of entries is 2nd November, 2017.
- 2.7 The participation to the contest is free of cost.
- 2.8 By taking part in the contest, the contestant agrees explicitly to the terms and conditions of participation of the contest.

3. Copyright and privacy rights

- 3.1 The contestants grant the Goethe-Institut / Max Mueller Bhavan the non-exclusive unrestricted right in terms of time, place and content for use of the video-clip submitted in the contest. This includes the right to copy and distribute the video-clip and the right to make the same available to the public via internet, including its use in promotional material and social media network of the Goethe-Institut / Max Mueller Bhavan (homepage, Facebook page, twitter page, Instagram, YouTube etc.). The right of use is granted free of charge. The Goethe-Institut / Max Mueller Bhavan shall be entitled to grant the aforementioned rights to third parties as deemed appropriate by the organisation. The Goethe-Institut / Max Mueller Bhavan shall mention the names of the contestants for any form of usage.
- 3.2 The contestants shall ensure, that the submitted video is free from any third party rights, in particular copyrights and other ancillary copyrights and that they are permitted to freely dispose of the video. As a matter of precaution, the contestants shall indemnify the Goethe-Institute against all third party claims, which are based on the fact that the above assurance does not apply.

- 3.3 The Goethe-Institut / Max Mueller Bhavan reserves the right to disqualify videos with immoral, unlawful, criminal and other content, which may infringe against criminal or liability law.
- 3.4 The Goethe-Institut / Max Mueller Bhavan is entitled but not obliged to use the video provided by the participant.

4. Jury and prizes

- 4.1. A jury shall select the two most original and creative videos as the winning entries. The decision of the jury is binding for all participants and cannot be contested.
- 4.2. **First prize:** Two winning teams will be selected from Kolkata. They will receive scholarships for an international Youth Camp to be held in 2018 in South Asia. The scholarship includes return airfare to the camp, German classes and workshops, sports, cultural and leisure program, accommodation with full board, round-the-clock support, full-day excursions and health- and accident insurance.
- 4.3. The winning schools and their respective winners will be informed by e-mail by 07.11.2017. The prizes will be given away during the live concerts of Raggabund on 11.11.2017 in Vidya Mandir, Kolkata. It is compulsory for the winner to be present at the concert and he/she has to confirm his/her presence at the concert latest by 08.11.2017 to sagarika.chatterjee@kolkata.goethe.org.
- 4.4 The winning entries will be published on the website and Facebook page of the Goethe-Institut / Max Mueller Bhavan.
- 4.5 Selected participants of merit will also be awarded exciting prizes. .

5. Disclaimer

- 5.1. The Goethe-Institut / Max Mueller Bhavan Kolkata cannot guarantee the availability and functioning of the contest. The contest may need to be stopped or removed due to external circumstances and constraints, without the contestants being entitled to any claims against the Goethe-Institut / Max Mueller Bhavan Kolkata. This includes organisational or technical problems (such as viruses in the computer system, manipulations or faulty hardware and/or software).
- 5.2. Liability of the Goethe-Institut / Max Mueller Bhavan Kolkata to compensation is subject to the following exclusions and restrictions, irrespective of other lawful eligibility requirements:

- So far as the damage was caused by intent or own gross negligence, the Goethe-Institut/ Max Mueller Bhavan Kolkata shall be liable without limitation.
- Furthermore, the Goethe-Institut / Max Mueller Bhavan Kolkata shall assume liability for the negligent breach of fundamental obligations, whose breach endangers the fulfillment of the intent of the contract or for the breach of obligations, the fulfillment of which make the execution of the competition possible in the first place and on whose observance the participants regularly rely. In this case, the Goethe-Institut / Max Mueller Bhavan Kolkata is liable only for the foreseeable damage which is typical of the contract. The Goethe-Institut / Max Mueller Bhavan Kolkata shall not assume liability for the negligent breach of obligations other than the ones stated in the preceding sentences.
- 5.3 The aforementioned exclusions of liability do not apply to injury to life, limb and health, to deficiencies in the case of granting a warranty for the condition of a product and to fraudulent concealment of deficiencies. Liability as under the Product Liability Act shall remain unaffected.
- 5.4 To the extent, that the liability of the Goethe-Institut / Max Mueller Bhavan Kolkata is excluded or limited, this shall also apply to the personal liability of the employees, representatives and assistants working for the Goethe-Institut / Max Mueller Bhavan Kolkata
- 5.5 The Goethe-Institut / Max Mueller Bhavan Kolkata reserves the right to end or extend the competition at any time without prior notice and without giving reasons.

6. Data security

- 6.1. The Goethe-Institut / Max Mueller Bhavan Kolkata shall comply with the legal regulations of data protection.
- 6.2. The contestants agree for the data submitted by them to participate in the contest to be stored, edited and transmitted as deemed necessary and appropriate for the competition by the Goethe-Institut / Max Mueller Bhavan Kolkata.
- 6.3. The data shall not be passed on to third persons for other than the previously mentioned purposes.
- 6.4. Contestants may at any time request information about which of their data has been stored by the Goethe-Institut / Max Mueller Bhavan Kolkata. Contestants may at any time withdraw their consent for storing their data and thereby withdraw from the competition.





7. Exclusion from the competition

- 7.1. Employees of the Goethe-Institut / Max Mueller Bhavan Kolkata as well as their relatives are excluded from taking part in the competition.
- 7.2. Persons, who (i) furnish false personal data, (ii) submit unlawful content or content that is conflicting with the conditions of participation, (iii) manipulate or misuse the electronic facilities provided for the contest shall be disqualified.

8. Final provisions

- 8.1. The organisers decision with regard to nominating the winners and announcing the results is final.
- 8.2. The organisation of the contest as well as the legal relationships of the persons taking part in the contest is governed exclusively by the laws of the Federal Republic of Germany, irrespective of the place from where a contestant participates.
- 8.3. Should one or several provisions of the above conditions of participation become invalid or unenforceable, the validity of the remaining conditions shall remain unaffected.
- 8.4. The above conditions for participation are provided in German and English language. In the event of inconsistency or discrepancy between both language versions, the German language version shall prevail.
