



TERMS AND CONDITIONS

ONE-TO-ONE TUITION AND SMALL GROUPS

1. Payment

- 1.1 Courses under 20 lessons are charged in full before the classes start. Courses over 20 lessons can be paid in 2 instalments, 50% on enrolment, and a second instalment halfway through the course. The Goethe-Institut London accepts cash, cheques, debit and credit cards.
- 1.2 Cheques should be made payable to the "Goethe-Institut London".
- 1.3 Payment must be received 3 days before the course starts. In some cases, a signed purchase-order may be deemed acceptable. We reserve the right to cancel the first lesson if payment has not been made in due time.

2. Course Fees

- 2.1 The contractually binding fee is the fee stated in the price list current at the time of application.
- 2.2 Unless stated otherwise books must be purchased separately.

3. Cancellation and refunds

- 3.1 In case of cancellation up to three days prior to the start of the course the course fee will be refunded. A minimum charge of £100 will be applicable to cover arrangement costs.
- 3.2 In case of cancellation or withdrawal after the course has started, no refunds will be issued.
- 3.3 Cancellations must be submitted in writing.
- 3.4 If the Goethe-Institut cancels a course the whole course fee will be reimbursed.

4. Course timetable

- 4.1 The minimum booking for a tailor-made course is 5 sessions of 90 minutes.
- 4.2 Tailor-made courses aim to provide top quality instruction at times and dates chosen by you. However, should unforeseen circumstances arise, you are permitted to make a limited number of changes to your schedule to provide further flexibility. A maximum of 10% of your total number of sessions may be changed without extra cost.
- 4.3 Cancellations must be received at least 24 hours in advance. For lessons taking place on Saturdays or Mondays, cancellations must be submitted by Thursday, 18:00 at the latest.

If a replacement cannot be found, the session will be rescheduled within the timeframe mentioned in §4.5.

- 5.2 You are entitled to free use of the study centre, located at the Goethe-Institut.
