**PARTICIPATION:** Artists and authors living in Greece can apply individually. Prerequisite is the submission of the complete application form until the end of the application deadline. Applications from students, unfortunately, cannot be considered.

**PERIOD OF THE WORKSHOP IN THESSALONIKI:** The workshop in Thessaloniki will take place on the 19<sup>th</sup>, 20<sup>th</sup> and 21<sup>st</sup> of March 2021. The dates for the workshops taking place in other countries of the Southeast Region are still not fixed and will be communicated in the near future.

**LANGUAGE:** Applicants should have excellent knowledge of English.

**TRAVEL EXPENSES:** For the trip to and from Thessaloniki, travel expenses will be reimbursed against corresponding vouchers. Accommodation for participants traveling from regions outside of Thessaloniki will be provided and covered by the Goethe-Institut.

Travel expenses and accommodation during the participation in one workshop of the Southeast Region will be covered by the Goethe-Institut.

**JURY:** The jury will meet after the application deadline and select the participants by February 8<sup>th</sup>. The jury's decision is final and will not be substantiated.

**NOTIFICATION:** No confirmation of receipt will be sent. Applicants will be notified by e-mail after the jury meeting. Applications which will be received after the deadline, cannot be accepted.
