TERMS AND CONDITIONS OF GOETHE-INSTITUT GERMAN COURSES AND EXAMS MUSCAT



Age - Exams offered by Goethe-Institut are designed, unless indicated otherwise, for participants aged 16 and older.

Data Protection - The course participant acknowledges that his/her registration information, billing data and performance data are electronically recorded by Goethe-Institut. The course participant agrees that Goethe-Institut continues to provide him/her with information and/or the newsletter.

Enrollment Requirements - Enrolment for the examinations shall be done at the published dates. All Fields in the registration form must be filled in as it appears in the applicant's passport. Incomplete or inappropriately-filled forms will not be accepted. The applicant shall be held responsible for any mistake in the application submitted. A passport copy must be presented with the registration form.

Terms of payment - The full price of the exam shall be paid upfront 7 days before the date of the exam itself. Fees can be paid in cash or per online transfer. Cheques and credit cards are not accepted as methods of payment.

Exam preparation material - Exam preparation material are not included in the fees of the exam. However, to help you prepare for the exam we encourage you to check our website for accessible and interactive sample papers and practice exercises. Certificate of Attendance - Participants who successfully pass the exam will receive an official Goethe-Zertifikat. Otherwise, an attendance confirmation will be issued. Kindly notice that the Certificate of Attendance is not equal to a Goethe-Zertifikat.

Release of Results - For quality assurance, it takes a whole week from the date of the exam for the results to come out. Please bear in mind that an individual exam results cannot be released before the designated date. It is also not possible to release the results per telephone or email.

Certificates pick up/ by post sending - Goethe-Zertifikate can only be handed in to the examinee. If the examinee wishes for a third party to pick it up on his/her behalf, they will have to fill in the Authorization Letter and bring it with a copy of the identification document. In case of not being able to come in person, please notice that we can also send the certificates by post against the postage fees of 6 OMR within Oman and 12 OMR to anywhere within the Gulf Region.

Identification during Examination - The participants must identify themselves with an item of official identification, which includes a photograph of themselves, before the beginning of the exam and at any other point as necessary.

Allowed Objects during Examination - Participants are asked to have the following stationery with them (a pen, a pencil, an eraser). They might also bring a bottle of water if they wanted to (label must be removed). Anything else is forbidden. Violation will result in exclusion from the exam.

Certificates required for German Embassy Appointments - Should you require the certificate for visa purposes, we advise you not to make an appointment with the German Embassy until the results are available. If you have an appointment already, please provide a proof upon registration, so we coordinate with the embassy accordingly.

Cancellation Policies: In case of cancellation or withdrawal 7 days before the exam's date, the cancellation is free of cost. 10% cancellation fees will be applied to any cancellation or withdrawal within the 7 days before the exam. The full amount paid upon registration will be counted as 100% cancellation fees for participants who did not show up for the exam.
