## TERMS AND CONDITIONS

### **Enrolment requirements**

- Please bring along **one** identification document (original passport or ID).
- Registration period for exams opens 4 weeks and closes 1 week prior to examination date.

### **Terms of payment / fees**

- The full examination fee is payable 5 business days before the exam date.
- Electronic transfers, swipe and cash are the only acceptable means of payment.

### **Cancellation and refunds**

- Cancellations must be submitted in writing.
- If an exam is not taken due to illness, the exam fee is credited to the next exam date. The relevant exam centre may charge an administration fee of up to 25% of the exam fee for the rebooking. The test participant reserves the right to prove that no losses have been suffered or that the loss is significantly lower than the lump sum.
- The full refund for the exam (all levels) and exam preparation fee is only obtainable until 1 week prior to examination date. No refunds will be processed after that.

### **Requirements on exam date**

- Participants without their original passport or ID will be excluded from the exam. A driver's licence will not be accepted.
- Body checks at the entrance of the examination room are mandatory for all candidates and visitors.
- All bags need to be placed at the back of the examination venue. Cell phones need to be switched off and may not be in the possession of the examination candidate during the exam.
- Taking unauthorised material into an exam will be regarded as attempted deception. Unauthorised material includes any notes/documents on your person and non-permitted equipment/devices.
- Talking or communicating with another student during an exam is strictly prohibited and may result in further actions being taken against the examination candidate.
- Participants are required to adhere to the exam schedule. Late comers will be excluded from the exam.

### **Participants with special Needs**

- Participants with special needs must inform the Goethe-Institut in writing of the type and extent of their special need at least 30 business days before the start of the exam.

### **Rewriting of exams**

- Participants that wish to rewrite an exam, need to complete a new registration form and submit together with proof of payment and a copy of valid passport or ID.

### **Exam results and Certificates**

- The exam results will be available within 5 – 15 working days. No exceptions will be made.
- Original passport or ID need to be shown on day of collection of certificate. If examination candidate is not able to collect the certificate him- or herself a written letter of authorisation needs to be provided by the person collecting the results on behalf of the examination candidate.
- The exam certificate may not be send via email, mail, fax, WhatsApp etc., since it is an official document.
- Exam results will not be released via email, mail or phone (social media and per telephonic conversation).
- Lost certificates cannot and will not be replaced.
