## Mathias Gustavsson (IVL Swedish Environment Institute)

Dr Mathias Gustavsson works as senior researchers at IVL Swedish Environmental Research Institute with projects on waste issues, sustainable energy, and transports with more than 20 years' experience. Mathias has been team leader and coordinator of several complex projects involving policy development and strategic planning linked to valorization of waste streams and energy sector. Other projects include feasibility and strategic studies on waste management, energy solutions and socio-economic impacts from improved waste management and recycling in Indonesia. He is currently part of the team of international experts that supports the Rethinking Plastics project on, among other things, EU policies and experiences on single use plastics.

Dr. Kim Thi Thuy Ngoc is working at the Institute of Strategy on Natural Resources and Environment (ISPONRE), Ministry of Natural Resources and Environment (MONRE)

## Ms. Trang Nguyen Thi Thu - MBA, Co-Founder and Deputy Director of GreenHub

Ms. Trang has been working in the environment and development sector with a focus on a plastic pollution in Vietnam for about 14 years. She has worked as Project Director in different waste management projects, programs in Vietnam and other countries for different donors and agencies including IUCN, DIG, CSIRO, The Sustainable Trade Initiatives – IDH, Coca-Cola Foundation and USAID. Currently, she as acted as Chief of Party for project funded by USAID called "Local Sollution for Plastic Pollution" to aim at building collective action from the ground up by strengthening and













uniting networks, communities and individuals through 1) environmental health literacy, 2) locally-determined and data-driven, solutions for advocacy, 3) policy, 4) business innovation, 5) combining traditional media and emerging communications technologies. She is facilitating the Plastic Action Network to mobilize knowledge-gathering, monitor plastics-related assessments and publications, and promote innovative solutions in 3Rs (reduce, reuse, recycle) and the Circular Economy. She has also invited by UNEP as an international trainer for 'Training of Trainers' in Marine Plastic Litter' for all ASEAN countries; and invited by the office of the National Assembly for policy advice on plastics waste, to update the national Law on Environmental Protection 2020.
