### **2. Course level assignment / class size:**

**2.1** Placement in course levels is based on the placement test conducted at the Goethe-Institut.

**2.2** A minimum number of 10 students per group is required to begin the course. Only a maximum number of 18 course participants will be allowed per course. If enrolment in a particular group is insufficient on the starting date, we reserve the right to adjust the course format! Should we not have enough course participants, we reserve the right to cancel a course!

### **3. Certificate:**

An 80% class attendance rate is required for the purpose of obtaining a confirmation of participation/certificate.

### **4. Terms of payment:**
