1. PROGRAMME BACKGROUND



1.1 About the Sub-Saharan Component, Connect & Create

The Sub-Saharan Component, Connect & Create of the Africa-Europe Partnerships for Culture programme is implemented by the Goethe-Institut in partnership with Expertise France and Institut français. This €8 million programme runs for 42 months (2025-2028) and promotes equitable dialogue and cooperation between African and European cultural actors, fostering co-creation, exchange, and mutual understanding.

1.2 Programme Objectives

Overall Objective: Contribute to improved Euro-African cultural cooperation, exchange, co-creation and dissemination with a view to promoting intercultural dialogue and mutual understanding.

Specific Objective: Create and improve Africa-Europe Culture Cooperation schemes and mechanisms that foster co-creation, co-production, exchange, capacity-building and dissemination amongst European and African artists, creators and culture actors.

1.3 Target Groups

The programme targets African and European artists, culture professionals and operators, with special attention to youth, women and persons with disabilities.

2. MOBILITY GRANT SCHEME DESCRIPTION

2.1 Purpose and Scope

This mobility scheme primarily supports transcontinental (Africa-Africa) short-term mobility for artists and culture professionals across all sectors. European artists and organisations may also apply, provided they have an existing partnership with an African artist, institution, or organisation. The scheme aims to strengthen partnerships within Africa, enhance career development, and create new opportunities for cultural exchange across Sub-Saharan Africa and with Europe.

2.2 Grant Information

Maximum Grant Amount: €4,000 per mobility

Total Grants Available: Up to **195 grants** over the programme period

Application Type: Rolling basis with regular quarterly cut-off dates

Coverage: **Physical**, **digital**, and **hybrid** mobilities

Geographic Focus: **Sub-Saharan Africa** (primary), **Europe** (secondary)

2.3 Call Timeline

Launch: 28 August 2025

Mobility Implementation Period:
October 2025 - December 2027





3. ELIGIBILITY CRITERIA

3.1 Applicant Eligibility

To be eligible, applicants must meet **all** of the following criteria:

01

Age:

18 years or older

02

Professional Status:

Artist or culture professional linked to artistic disciplines including:

Visual arts, performing arts, music, literature, film, media arts, cultural heritage, design, architecture, fashion design

03

Geographic Requirement:

Currently based in Sub-Saharan Africa OR in the European Union

04

Application Format:

Individual artists or teams may apply.

05

Destination Connections:

Must have established connections or invitations in destination country

06

Clear Purpose:

Must demonstrate clear mobility purpose that aligns with programme

3.2 Eligible Countries

Sub-Saharan Africa: All countries in Sub-Saharan Africa are eligible

European Union: All EU Member States are eligible

3.3 Non-Eligible Applicants

- Applicants under 18 years of age
- Staff or family members of Goethe-Institut, Expertise France, Institut français, or European Commission
- Entities under EU restrictive measures
- Previously excluded from EU-funded projects

4. ELIGIBILITY ACTIVITIES



Mobility grants may support the following activities:

4.1 Artistic and Professional Development

- Research of cultural heritage, cultural ecosystems, and practices to inform or inspire artistic creativity
- Co-creation or co-development purposes with artists from other countries
- Participation in non-formal learning programmes
- Development or reinforcement of international professional relationships

4.2 Cultural Exchange and Networking

- Invitation to take part in residencies, exhibitions, or other art world events
- Professional conferences, workshops, or training programmes
- Collaborative projects with international partners

4.3 Mobility Types Supported

- **Physical Mobility:** Traditional travel-based exchanges
- **Digital/Virtual Mobility:** Online residencies, virtual collaborations, digital cultural exchanges
- **Hybrid Mobility:** Combination of physical and digital components

5. BUDGET FRAMEWORK

5.2 Eligible Costs

Travel Costs:

- International and domestic travel expenses
- Visa and insurance costs (actual costs, refund basis)

Accommodation

Lump sum rates apply:

Sub-Saharan Africa: **€70 per night**

European Union: **€141 per night**

Subsistence:

Lump sum rates apply:

Sub-Saharan Africa: **€25 per day**

European Union: **€49 per day**

Digital/Connectivity Costs:

- Data packages for digital/hybrid mobilities
- Platform subscriptions for virtual collaborations
- Technical equipment rental (where necessary)

5.3 Top-up Support Available

- **Family Support:** Additional funding for childcare to enable participation
- **Disability Support:** Additional funding to cover extra costs linked to physical disabilities
- **Green Mobility:** Additional support for environmentally sustainable travel options

5.4 Co-funding

Applicants may have additional funding sources, but must declare all other funding received for the same mobility project.

6. AWARD CRITERIA

6.1 Artistic Quality and Innovation (25%)

- Artistic quality of proposed activities and their relevance to international audiences
- Innovation, cooperation, and experimentation with new forms of artistic expression
- Integration of digital approaches where appropriate

6.2 Relevance and Necessity (25%)

- Extent to which the project relates to AEPC SSA Connect & Create objectives
- Necessity of the mobility to achieve stated objectives
- Clear connection between mobility activities and professional/artistic development

6.3 Quality of Preparation (20%)

- Thoroughness of mobility planning and preparation
- Quality of partnerships and connections in destination country
- Realistic and well-structured timeline

6.4 Longer-term Impact (20%)

- Potential for opening opportunities and networking
- Expected career development outcomes
- Contribution to lasting partnerships (international and local)
- Community engagement and knowledge transfer

6.5 Technical Capacity (10%)

- Demonstrated ability to implement proposed activities
- Track record in relevant artistic/professional field
- Administrative capacity to manage grant requirements

6.6 Cross-cutting Considerations

Final selection ensures:

Geographic Diversity: Balanced representation across eligible countries

Gender Equality: 50% female participation target

Inclusion: Priority for applicants with disabilities, from socio-economically disadvantaged backgrounds, or beyond urban centres

Career Stage Diversity: Balance between emerging, mid-career, and established professionals

Linguistic Diversity: Representation across different linguistic areas

7. APPLICATION PROCESS



7.1 How to Apply

Application Portal: **Applications must be submitted via the Goethe-Application Portal (GAP)**

Language Requirements:

- All applications must be submitted in English
- Supporting documents in other languages must include certified English translations
- Translation support available for applicants

7.2 Application Requirements

Mandatory Documents:

- Completed online application form
- Portfolio/work samples (via upload or online links)
- CV/biography (via upload or professional profile links)
- Letter of invitation/support from destination country
- Project timeline/schedule
- Valid identity document
- Detailed budget breakdown

Optional Documents:

- Additional portfolio links
- Letters of support from partners
- Previous collaboration documentation

8. SELECTION PROCESS

8.1 Selection Process

Stage 1: Eligibility Check

- Administrative compliance review
- Eligibility criteria verification
- Document completeness assessment

Stage 2: Technical Evaluation

- Assessment against award criteria
- Budget review for cost-effectiveness
- Risk assessment

Stage 3: Selection Committee Review

- External expert jury evaluation
- Geographic and demographic balance review
- Final selection and ranking

8.2 Selection Committee Composition

The Selection Committee comprises:

- Cultural sector experts from Africa and Europe
- Representatives of relevant cultural networks
- Goethe-Institut technical specialists
- Independent external evaluators

Committee composition ensures:

- Gender balance
- Geographic representation
- Sectoral expertise diversity
- Linguistic diversity

8.3 Evaluation Timeline

Per Cut-off Cycle:

- Applications close: Cut-off date at 23:59 CET
- Evaluation period: 6-8 weeks post cut-off
- Results notification: Within 10 weeks of cut-off
- Mobility implementation: From 2 months post-notification



9. GRANT AGREEMENT AND IMPLEMENTATION

9.1 Grant Agreement

Successful applicants will sign a grant agreement specifying:

- Grant amount and payment schedule
- Project implementation requirements
- Reporting and monitoring obligations
- Visibility and communication requirements
- Intellectual property arrangements

9.2 Payment Schedule

Instalment Structure:

- **1st Payment (60%):** Upon grant agreement signature
- **2nd Payment (40%):** Upon completion of mobility and submission of final report

Payment Conditions:

- All payments subject to satisfactory progress
- Documentation of expenses required
- Compliance with grant agreement terms

9.3 Reporting Requirements

Interim Reporting: Progress update at mobility midpoint (for mobilities >30 days)

Final Report: Due within 30 days of mobility completion

Financial Reporting: Expense documentation and receipts

Impact Assessment: Outcomes and lessons learned documentation

9.4 Monitoring and Support

Grantee Support:

- Mandatory orientation workshop for successful applicants
- Regular check-ins via GAP Portal
- Technical assistance throughout implementation
- Networking opportunities with other grantees

Quality Assurance:

- Regular project monitoring
- Compliance verification
- Risk assessment and mitigation
- Performance evaluation
