

# GOETHE-INSTITUT GULF REGION

## TERMS & CONDITIONS



### AGE:

Courses offered by Goethe-Institut Gulf Region are designed, unless indicated otherwise, for participants aged 16 and older.



### NUMBER OF PARTICIPANTS:

Face- to-face courses adults & teenagers: maximum 16, minimum 5 participants. Face-to-face courses children: maximum 12, minimum 5 participants. Online courses adults & teenagers: maximum 14, minimum 5 participants. Online courses children: maximum 10, minimum 5 participants. Goethe-Institut Gulf Region reserves the right to cancel a course date if the minimum number of participants has not been attained upon expiration of the enrolment procedure. In case Goethe-Institut Gulf Region cancels the course date, the total course fees will be reimbursed to the participant. Further claims are excluded.



### PRICES:

The current prices at the time of enrolment are applicable. The costs for the textbooks are not included in the price of a course.



### ENROLMENT:

Enrolment for the courses shall be done at the published dates. A valid passport or ID is required to complete the registration. In the case of minor participants, the legal guardians must give their consent. Participants without previous knowledge shall start a course at level A1.1. Participants with previous knowledge take the placement test of the Goethe-Institut Gulf Region and are then assigned to the appropriate course level.



### PLACEMENT TEST:

A placement test is subject to charge. The fee will be allocated to the course booking. The placement test merely serves to support the placement in the appropriate course and does not replace any certificate of language skills. The results of the placement test are valid for six months only.



### TERMS OF PAYMENT:

The total course price shall be paid by credit card or bank transfer at the agreed date of payment (normally on the day of enrolment) before starting the lessons. Cheques are not accepted as payment. In case of payment from abroad, the sender is liable to bear any currency conversion costs or other charges incurred in making the payment.



### CHANGE OF COURSE:

A change of course shall only be possible subject to the number of seats available and only after prior consultation with the course instructors and the language course office.



### CANCELLATION AND REFUND:

Withdrawal from a course shall be declared in writing and informally to Goethe-Institut Gulf Region. For minor participants, the written consent of the legal guardians must be obtained. In case of withdrawal prior to the first course day, the course fee less an administration fee of 10% of the course fee will be reimbursed. In case of withdrawal on the first course day or following the course commencement, a refund is no longer possible. Refunds will be processed according to the original payment method.



### CERTIFICATE OF COURSE ACHIEVEMENT:

Participants will receive a qualified certificate of attendance. Regular attendance is a prerequisite for this certificate (70% of the course dates) as well as passing of at least two tests. A grade of 60% overall is required to pass a course. In an online course, log-in without visual and oral participation will be considered as absence. Course certificates will be kept by Goethe-Institut Gulf Region for 1 year only.



### PREREQUISITES FOR ONLINE COURSE ATTENDANCE:

A desktop PC or laptop with a working camera and proper audio (microphone) is required as students are expected to fully participate in the class. Switching on the camera is mandatory in all courses.



### PUBLIC HOLIDAYS:

Dates of the Islamic holidays depend on official announcements by the religious authorities in the United Arab Emirates and can vary based on such announcements. Courses that do not take place on such days usually run for a longer period. Goethe-Institut Gulf Region is not obliged to provide individual make-up lessons.



### HANDLING COMPLAINTS:

For complaints regarding the courses at Goethe-Institut Gulf Region, please contact the language course office.



### DATA PROTECTION:

The course participant acknowledges that his/her registration information, billing data, and performance data are electronically recorded and processed across all offices of Goethe-Institut Gulf Region. The course participant agrees that Goethe-Institut Gulf Region continues to provide him/her with information and/or the newsletter.



### LIABILITY:
