

## WAIVER AND INDEMNITY – GIS YOUNG LEARNERS



**To: Goethe-Institut Singapore**

**In consideration of you, Goethe-Institut Singapore, having its premises at 136 Neil Road, Singapore 088865, (hereinafter referred to as the "Institution") providing German language lessons to my child/children named herein, I do hereby agree as follows:**

1. I understand that my child/children shall travel to and / or from the Institution at my own risk and not at the risk of the Institution.
2. I agree to ensure that my child / children are supervised and accompanied to his/her class within the Institution and picked up thereafter. In this regard, I understand that my child / children would not be supervised by any Institution staff prior to or after classes. Any choice to allow my child to attend and to leave classes at the Institution unattended or unaccompanied is wholly at my own risk.
3. The Institution shall not be liable for
  - a. any death or injury, except when the same results from its own or its employee's negligence.
  - b. any incident, which arises from a reason beyond its reasonable control or from an act or default from my child/children.
  - c. any special, indirect or consequential loss whatsoever, even if such loss had been reasonably foreseeable or if the Institution had been advised of the possibility of the occurrence of the same.
  - d. any damage or loss caused to my child's personal belongings, however caused, whilst my child/children is in the Institution's premises. I agree in this regard to duly instruct my child / children to take proper care of his/her belongings and not to leave the same unattended at all times.
4. I hereby release the Institution from any and all claims, demands, damages, costs, actions or causes of action on account of or arising from any of the matters contained hereinabove, including such action that may be taken by the Institute subsequent to any accident or incident in which personal injury has occurred.
5. In the event of any emergency, I do hereby authorize the Institution to arrange such medical attention for my child/children as may be reasonable and available in the circumstances and I undertake to pay all medical and hospital fees and incidental charges in respect of medical attention given to my child/children and to reimburse the Institution for any such fees and charges and all incidental costs and expenses which may have been paid by the Institution.
6. I further agree to indemnify the School against any and all claims, demands, damages, costs, actions or cause of action which my child/ children, his/her next-of-kin, parent, guardian, personal representatives and/or dependents may bring, make or have against the Institution on account of any matters stated above.
7. Reference herein to the Institution shall include references to the Institution, its office bearers, employees, agents and other persons authorized by the Institution from time to time.
8. Nothing in the above document shall limit the right of any child/children, next-of-kin, parent or guardian, personal representative and/or dependents to take action against any third party (other than the Institution) or their officers, employees, agents or other persons authorized to act their behalf.
9. A person who is not a party to this Agreement shall have no right by virtue of the Contracts (Rights of Third Parties) Act or otherwise to enforce any of the terms herein.
